Major Community Development Projects for City of Denver

- Creation of the Lafayette Street Historic District, 1987
This project, among others, led to the historic awards mentioned above.
- Kaiser Permanente Planned Use Development, 1990
Worked with Kaiser, various city agencies, neighbors and the city council to allow creation of a Planned Unit Development which allowed Kaiser to expand while at the same time minimizing the adverse impact on the surrounding residential neighborhood.

- Revision of Denver Zoning Code as pertains to hospitals, 1991
Was driving force to have hospitals removed as a use by right in residential neighborhoods. This zoning language amendment allowed hospitals to expand in an organized fashion if needed and at the same time mandated buffers with the surrounding residences and minimized institution caused urban blight.
- Uptown Hospital District Urban Design Plan, 1993
Was part of the executive committee that drafted this urban design plan which was then incorporated into the Comprehensive Plan for the City of Denver by the Denver City Council.
- Uptown Hospital District Urban Design Plan Update 2007. *Was part of the executive committee that drafted this urban design plan designed to guide the redevelopment of the Childrens Hospital site. This is one of the guiding documents governing the redevelopment of the St Joseph site.*

This is an ongoing committee made up of representatives of the City of Denver, Neighborhood groups and medical institutions to advise on land use planning in the area surrounding the downtown hospitals.
- Revision of Denver Zoning Code as pertains to non-hospital medical facilities 1994
Was part of the executive committee that revised the Denver Zoning code to extend zoning regulations to include large medical clinics, outpatient surgical centers and other non-hospital medical land uses.
- Rezoning and Street Vacation for Kaiser Expansion 1995
Was instrumental in the design and approval by Denver City Council of an expansion for Kaiser Permanente which followed the Urban Design Plan and channeled existing and new medical traffic out of the residential neighborhood.
- St Luke's Hospital Redevelopment. 1996-7
Served in a leadership role with the committee which defined an urban renewal district including the ten acres of the St Luke's campus and ten acres of surrounding blight and then had the district approved by City Council. This bill allowed for tax increment financing of infrastructure improvements. Facilitated negotiations between Columbus Realty Trust, Columbia/HealthOne and the HealthOne board to enable construction of market rate housing within walking distance of the central business district and the medical institutions. Led the team of neighborhood leaders in negotiations with Denver Housing Authority concerning public housing projects in the District.
